**PATH Intl. Registered Level Instructor Workshop  
August 15-17, 2020**

This 2½ day comprehensive workshop will enhance the knowledge base of therapeutic riding instructors and is a prerequisite for the PATH Intl. Registered Instructor Certification. The workshop is also useful for individuals seeking to learn more about the field but who are not yet ready to complete the certification process. Come spend valuable time with colleagues in the field of equine assisted activities and therapies. This is a great opportunity to learn and share techniques in a warm and welcoming teaching environment. *PATH Intl. membership required.*

**PATH Intl. Registered Level Instructor Certification:**

**Monday Afternoon, August 17 and all day Tuesday, August 18, 2020**

The Certification is open to 8 participants who have completed the PATH Intl. Instructor Workshop (during this offering or at a previous workshop) along with all other certification criteria (see details on Phase I and II). **The riding tests will be given on the afternoon of August 17<sup>th</sup>** and the Certification candidates will draw their teaching assignments for testing held on the 18th. With successful completion of the Certification, participants become PATH Intl. Registered Level Instructors.

**Certification Candidates** are registered on a first come-first served basis. Space is limited to 8 so please register early. Submit your Certification Application and all the completed paperwork along with your registration. Incomplete applications cannot be accepted.

## **PATH Intl. Registered Level Instructor Certification Process**

In order to become a **PATH Intl. Registered Level Instructor**, you must successfully complete **Phase I and II** of the certification process. **All candidates enrolling in RTT's OSWC must have completed Phase I prior to October 30, 2019.**

### **Phase II (Riding To The Top)**

Within **12 months** of finishing Phase I, you must **complete all the components of Phase II**. These components are:

- Completion of **25 hours of practice teaching mounted therapeutic riding lessons** under the guidance of a PATH Intl. Certified Instructor
- Attendance at a **Registered Instructor On-Site Workshop** *prior* to the Certification evaluations
- Completion of a **Registered Instructor On-Site Certification**
